## FUND OBJECTIVE

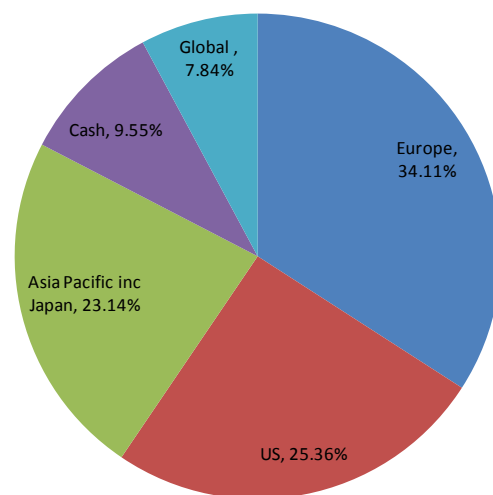
The Coronation Global Equity Alternative Strategy Fund seeks to achieve long-term capital growth by investing in long/short equity hedge funds. The fund is highly focused, with around 10 underlying hedge fund managers, but is well diversified across manager investment styles and exposure to market direction. All managers are high quality, "blue chip" funds with well-established track records and asset bases, whilst over 80% of these are closed to new investors. The fund is suitable for investors seeking a combination of superior returns and capital preservation.

## GEOGRAPHICAL ALLOCATION

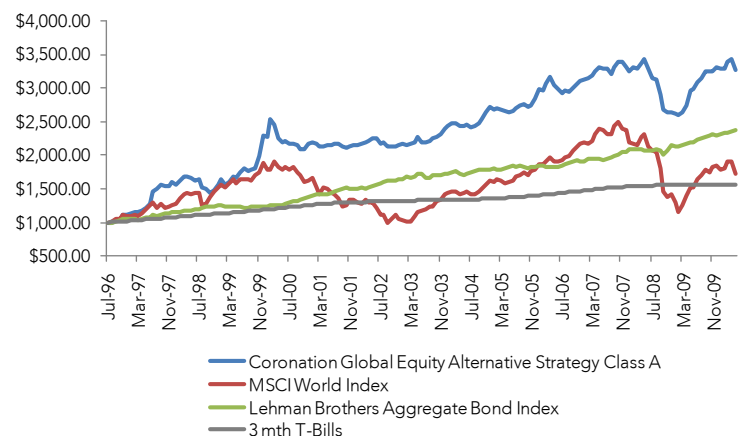
