FUND OBJECTIVE

The Coronation Global Equity Fund of Funds invests in long-only equity funds covering the US, Europe and Far Eastern markets. The fund allocates to about 10 funds and is well-diversified across geography, sector allocation, and manager styles. Fund managers have well-established track records and have been thoroughly evaluated by Coronation's due diligence team. Since inception the fund has outperformed its benchmark, the MSCI World Index (dividends reinvested). The fund is suitable for investors seeking exposure to a diversified portfolio of top global talent in the equity space.

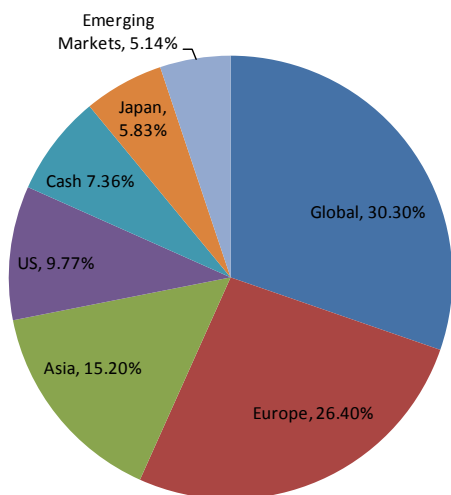

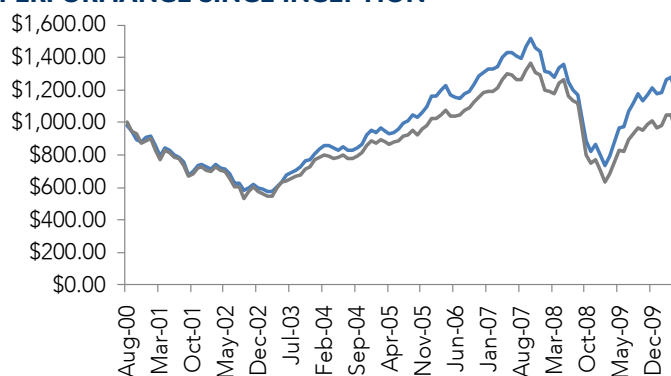

GEOGRAPHICAL ALLOCATION

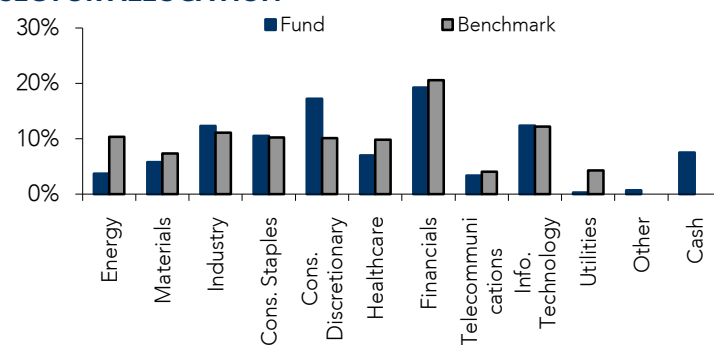


PERFORMANCE SINCE INCEPTION
