FINANCIAL RESULTS FOR THE YEAR ENDED 30 SEPTEMBER 2021 AND CASH DIVIDEND DECLARATION

1. SALIENT FEATURES

Revenue increased by 17.1% to R4,263 million, from R3,642 million in the prior corresponding period.

Headline earnings per share increased by 22.4% to 487.9 cents per share, from 398.5 cents per share in the prior corresponding period.

Earnings per share increased by 22.4% to 487.9 cents per share, from 398.5 cents per share in the prior corresponding period.

Fund management earnings are used by management to measure operating financial performance, which excludes the net impact of fair value gains and losses, and related foreign exchange, on investment securities held. Fund management earnings per share increased by 22.9% to 470.9 cents per share, from 383.1 cents per share in the prior corresponding period.

Gross dividends per share increased by 22.7% to 470 cents per share, from 383 cents per share in the prior corresponding period.

2. DIVIDEND DECLARATION

The directors resolved to declare a final gross dividend of 226 cents (2020: 205 cents) per share from income reserves in respect of the year ended 30 September 2021. The dividend amount, net of South African dividend tax of 20%, is 180.8 cents (2020: 164.0 cents) per share for those shareholders who are not exempt from dividend tax. The number of ordinary shares in issue at the declaration date is 349 799 102 and the income tax number of the Company is 9 675 107 719.
